## Executive Functions in Children and Adolescents with Turner Syndrome: A Systematic Review and Meta-Analysis

## 11 Abstract

Turner syndrome (TS) is a genetic disorder, affecting 1/2500 to 1/3000 live female births, induced by partial or total deletion of one X 1213chromosome. The neurocognitive profile of girls with TS is characterized by a normal Verbal IQ and weaknesses in visual-spatial, mathematics, and social cognitive domains. Executive functions (EFs) impairments have also been reported in these young patients. 14 However, methodological differences across studies do not allow determination of which EFs are impaired and what is the magnitude 1516of these impairments. The aim of this review was to clarify the EF profile of children and adolescents with TS. Sixteen samples, from 17thirteen studies, were included in the current meta-analysis. EFs measures used in these studies were classified into working memory, 18 inhibitory control, cognitive flexibility, or higher-order EFs tasks in accordance with Diamond's model, Annual Review of Psychology, 1964, 135–168 (2013). Results confirmed that girls with TS had significant executive impairments with effect sizes varying from small (inhibitory control) to medium (cognitive flexibility) and large (working memory, higher-order EFs). Analyses by task revealed that 20cognitive inhibition may be more impaired than the other inhibitory control abilities. Heterogeneity across cognitive flexibility 2122measures was also highlighted. Between-sample heterogeneity was observed for three tasks and the impact of participants' characteristics on EFs was discussed. This meta-analysis confirms the necessity to assess, in patients living with TS, each EF by combining 2324both visual and verbal tasks. Results also underline the importance of exploring the impact of moderator variables, such as IQ, parental 25socio-economic status, TS karyotype, psychiatric comorbidities, and hormonal treatment status, upon girls with TS' executive profile.

Turner syndrome (TS) is a common genetic disorder, caused by partial or complete monosomy X, affecting approximately 1/2500 to 1/3000 live female births (Sybert and McCauley 2004). The physical phenotype is commonly characterized by short stature and abnormal pubertal development, as well as a

webbed neck, and cardiovascular, renal, endocrine, and ear ab-33 normalities (Bondy 2007). The neurocognitive profile of chil-34dren and adolescents living with TS often includes a normal 35Verbal IQ contrasting with an impaired Performance IQ (see 36 Hong et al. 2009, for a review). Poor mathematics performances 37 (e.g. Mazzocco 1998; Murphy et al. 2006) and deficits in visual-38 spatial skills (e.g. Green et al. 2014; Romans et al. 1998), social 39cognition (e.g. Hong et al. 2011; McCauley et al. 2001), and 40 executive functions (e.g. Romans et al. 1997; Temple et al. 41 1996) have been also described in this pediatric population. 42

The concept of executive functions (EFs) refers to a set of 43interrelated abilities mainly mediated by the prefrontal and pa-44 rietal parts of the brain (Collette et al. 2006), regions in which 45structural and functional abnormalities have been highlighted in 46 children and adolescents with TS (Bray et al. 2011; Haberecht 47 et al. 2001; Kesler et al. 2004, 2006; Lepage et al. 2013a; Tamm 48 et al. 2003). EF abilities are described as a group of top-down 49 mental processes, acting as a regulation system, which enable 50people to "formulate goals; to initiate behavior; to anticipate the 51consequences of actions; to plan and organize behavior 52

53according to spatial, temporal, topical, or logical sequences; and to monitor and adapt behavior to fit a particular task or context" 54(Cicerone et al. 2000, p.1605). According to highly influential 55frameworks in current literature (e.g. Lehto et al. 2003; Miyake 5657et al. 2000), EF is not a unified construct. Rather, EF is com-58prised of several correlated yet separable core functions that include updating working memory, shifting, and inhibition. 59Such three-factor models of EFs are not comprehensive and 60 61 the inclusion of other EFs has been explored. In this vein, Diamond (2013) positioned EFs in a hierarchical framework 6263 in which results of the three core functions mediate higherorder EFs such as planning, problem solving, and reasoning. 64

One of the core EFs is working memory (WM) defined by 6566 Diamond (2013) as the capacity to keep in mind information, verbal or visual-spatial, that is not perceptually present and to 67 work with it. For example, the Self-Ordered Pointing Task 68 69 (SOPT, Petrides and Milner 1982) is a WM task in which several sheets of paper, containing an identical set of pictures in 70 various positions, are presented successively to participants. All 7172of these stimuli have to be pointed, but each picture only once and one picture at a time per page. Therefore, the participants 7374must memorize their previous answers and update information 75at each new sheet to avoid pointing to an item already touched in 76previous pages. Another core function in Diamond's (2013) model is inhibitory control which enables both suppression of 77 a prepotent representation (cognitive inhibition), control of at-78tention (selective or focused attention), and self-control that in-79volves, among others, not acting impulsively (response 80 81 inhibition). For instance, the flanker task can be considered as a common inhibition task. It requires participants to report the 82 direction of an arrow (the target) flanked by irrelevant arrows 83 pointing either in the same or in the opposite direction as the 84 target. Thus, they have to focus attention on the relevant infor-85mation and ignore other stimuli. According to Diamond (2013), 86 WM and inhibitory control are supposed to be involved in a 87 88 third core EF, cognitive flexibility, which refers to the ability to switch between mental sets or strategies. In that sense, the Trail-89 90 Making Test (TMT), which requires participants to draw a line 91 between numbered circles in sequential order in the first part of the task and between circles that alternate numbers and letters in 92the second part of the task, allows investigation of cognitive 93 flexibility. Higher-level EFs such as reasoning, problem solving, 94and planning are supposed to be underpinned by these three core 95EFs (Diamond 2013). All of these functions may play a crucial 96 97 role in school success, and more widely, in daily life, allowing to 98 adopt appropriate reactions and behaviors. Diamond's (2013) EFs model can be useful to improve our understanding of some 99 of the underlying mechanisms behind poor mathematics perfor-100 mances (Baker and Reiss 2016) often reported in children and 101 102adolescents with TS as well as their difficulties in social and 103 interpersonal functioning (Lepage et al. 2013b).

104 Challenges for the investigation of EFs emerge from the fact105 that executive tests involve different types of EFs, yet it remains

difficult to determine which executive process contributes most 106to task achievement. For example, the Wisconsin Card Sorting 107Test (WCST), widely used in research and clinical practice as a 108measure of hypothesis generation and ability to shift response 109(Goldstein and Green 1995), was initially introduced to explore 110problem-solving and decision-making abilities (Berg 1948; 111 Grant and Berg 1948). In addition, executive tasks are not pure 112measures of a single skill, and as a result, an individual's exec-113utive performance can be contaminated by non-executive re-114quirements of the task (Burgess 1997). Given evidence for im-115paired visual-spatial ability in patients with TS (see Hong et al. 1162009 for review), which might affect executive tasks requiring 117visual-spatial processing, it could be interesting to consider the 118 impact of procedural aspects on EF performance. Furthermore, 119another point to consider is that in some EF tasks participants 120have to provide a response as quickly as possible. The nature of 121the relation between processing speed and EFs is controversial 122and remains to be specified (Lee et al. 2013). As reviewed by 123Mazzocco (2006), a lower processing speed has been described 124in girls with TS. Therefore, it remains unclear if poor perfor-125mances in executive timed tasks reflect specific EFs difficulties 126or if these results are mediated by deficits in processing speed. 127

While there has been an increasing interest in EF abilities of<br/>children with TS over the last two decades, existing studies120have shown mixed results regarding the nature of these exec-<br/>utive deficits (Romans et al. 1997; Temple et al. 1996).131Furthermore, the magnitude of the effect size (ES) of execu-<br/>tive dysfunction in this population remains unclear.134

WM impairments in girls with TS were reported in the vast 135majority of studies using digit span tasks (Lepage et al. 2011; 136Loesch et al. 2005; McCauley et al. 1987; McGlone 1985; 137Murphy and Mazzocco 2008; Romans et al. 1997; Romans 138et al. 1998; Ross et al. 1995, 2000; Rovet 1993; Rovet et al. 1391994) or other WM tasks such as n-back tasks (Bray et al. 1402011; Haberecht et al. 2001), or the abstract version of an adap-141tation of the SOPT (Temple et al. 1996). Results are less conclu-142sive for the other EFs. 143

Response inhibition, within inhibitory control functions, is 144the most studied in children with TS using tasks assessing im-145pulsivity. One study (Romans et al. 1998) reported that partici-146pants with TS responded faster than controls in the Matching 147 Familiar Figures Test (MFFT). Moreover, the number of com-148mission errors was significantly higher in the TS group in the 149Test of Variables of Attention (TOVA: Romans et al. 1997, 1501998). Yet, these findings are not consistent and other studies 151reported no significant difference between girls with TS and 152controls in these same tasks (MFFT: Romans et al. 1997; Ross 153et al. 1998, 1995 - TOVA: Ross et al. 1995), as well as in a Go-154NoGo task (Tamm et al. 2003). Concerning the other aspects of 155

inhibitory control, these processes have been less often explored. Girls with TS may have cognitive inhibition impairments, highlighted by the Stroop task (Temple et al. 1996;
Waber 1979). Finally, selective attention deficits were also reported on a flanker task (Quintero et al. 2014) and on the Auditory Attention and Response Set subtest and Visual Attention subtest from the NEPSY (Green et al. 2015).

Evidence for poorer performance on set-shifting tasks appear 163to be contingent upon task selection. Hence, the majority of stud-164165ies assessing cognitive flexibility using verbal fluency tasks indi-166cated deficient performance among TS samples for phonemic (Bender et al. 1989; Romans et al. 1997, 1998; Temple et al. 1671996; Temple 2002; Waber 1979) and semantic fluency (Rae 168169et al. 2004; Romans et al. 1998; Temple et al. 1996). Girls with TS had more difficulties than control participants in the TMT 170(Bender et al. 1993) and in the Same-Opposite world subtest from 171172the Test of Everyday Attention for Children (Skuse et al. 1997). In contrast, some studies using the WCST as an indicator for 173flexibility revealed no difference between TS and control groups 174175(McGlone 1985; Romans et al. 1997, 1998; Temple et al. 1996), although results are not consistent (Bender et al. 1993; Loesch 176177et al. 2005; Waber 1979). Performance is also heterogeneous with 178the Contingency Naming Test (CNT), where girls with TS obtained lower results than the control group in the two-attribute 179trials in two studies (Kirk et al. 2005; Mazzocco and Hanich 180 2010) but not in another (Murphy and Mazzocco 2008). 181

Higher-level EFs have been assessed in children with TS 182with the Rey-Osterrieth Complex Figure (ROCF) and different 183 problem-solving tasks such as the Tower of Hanoi (TOH), the 184Tower of London (TOL) or the Tower subtest from the NEPSY. 185 In most studies (Bishop et al. 2000; Loesch et al. 2005; Reiss 186187 et al. 1995; Romans et al. 1997, 1998, 1995, 1997a; Waber 1979), but not all (McGlone 1985), girls with TS had more 188difficulties than controls to reproduce the ROCF. Concerning 189the TOH and its variants, some studies did not find any differ-190191ence between the TS group and the controls (Temple et al. 1996; Green et al. 2015; Skuse et al. 1997), while in others, girls with 192TS obtained lower results (Romans et al. 1997, 1998). 193

In TS, differences between studies assessing EFs may be explained, in part, by methodological choices concerning executive tasks, for example, visual or verbal modality, or limited response time. Yet, participant characteristics (age, IQ, parental socioeconomic status, karyotype, hormonal treatments, and psychological co-morbidities) could also explain discrepancies in results.

# 201 Moderator Variables of Executive Functions202 in Turner Syndrome

The development of EFs occurs during the first year of life and goes on until the beginning of adulthood, each EF has its own developmental calendar (Best and Miller 2010). It is plausible to expect that in TS, developmental changes may not follow the 206same curve as control children and, as age advances, differences 207between children with TS and their peers may increase or re-208duce. Hence, heterogeneity of results could be explained by 209variability of participants' age between studies assessing EFs 210in TS (e.g. Skuse et al. 1997: age range from 6 to 25 years). 211Even if in the vast majority of studies, TS and control groups 212have been matched by age, in some studies (e.g. Kirk et al. 2132005; Murphy and Mazzocco 2008) the two groups were 214matched by full scale IQ. This IQ-matching criterion could have 215an impact on the magnitude of the ES on EF tasks. 216

Processing speed, likely to have an impact on EFs, and 217other aspects of EFs, such as WM abilities, are considered as 218part of intelligence constructs (Floyd et al. 2010; McGrew 2192009). Thus, these processes are assessed in intelligence test 220batteries (e.g. Wechsler 2014). When the TS group and con-221trols were matched on IQ, differences between the two groups 222in some EF tasks may be lower in comparison to other studies 223 in which controls had higher IQ than girls with TS. Moreover, 224considering IQ scores as matching criteria could lead to the 225inclusion of unrepresentative participants. For example, in-226cluding healthy children with slightly lower IQ scores than 227expected (Dennis et al. 2009) can be misleading. 228

Another variable, which may also have an impact on EFs, 229is parental socioeconomic status (SES). Depending on the EF 230 tasks (Ardila et al. 2005), children from families with low SES 231have more EF difficulties than children from well-off families 232(Hackman and Farah 2009; Sarsour et al. 2011). If girls with 233TS present some EF impairments, differences between these 234girls and control participants may be lower in studies in which 235participants with TS have significantly higher SES than con-236trols. Inversely, differences between the control and TS groups 237 may increase if controls are from well-off families and patients 238with TS are not. 239

Other characteristics, specific to children and adolescents 240with TS, should be also taken into account in EF assessment. 241In TS, the anomaly affecting one of the two X chromosomes 242can be present in all cells or only one part (mosaicism). The 243hypothesis of cognitive differences between different TS kar-244 yotypes has been explored in several studies in which girls 245with 45,X monosomy were compared to girls with mosaic 246karyotypes and girls with other TS karyotypes (e.g. X partial 247deletion or X translocation). Regarding intellectual abilities, 248girls with a ring X chromosome had more verbal and non-249verbal difficulties than girls with 45,X monosomy (Kuntsi 250et al. 2000). These latter obtained significantly lower scores 251than girls with mosaicism on the Wechsler Intelligence Scale 252for Children, Fourth Edition (WISC-IV)'s perceptual reason-253ing and WM indexes (Bray et al. 2011). Children with struc-254tural abnormalities of X chromosome (translocation, isochro-255mosome, partial deletion) had higher Verbal IQ than ones with 256X monosomy or mosaicism (Messina et al. 2007). Compared 257to the other karyotypes, 45,X monosomy has been associated 258

259with an increase of visual-constructive and visual-perceptual deficits (Ross et al. 1997a; Temple and Carney 1995), verbal 260episodic memory impairments (Ross et al. 1995) and visual-261spatial WM difficulties (Buchanan et al. 1998; Temple et al. 262263 1996). However, several studies reported that karyotype did 264not significantly impact IQ (Lahood and Bacon 1985; Temple 2002; Zhao et al. 2013) or cognitive flexibility abilities 265(Temple 2002). In children with 45,X monosomy, the influ-266267ence of X chromosome parental origin has been explored and, 268as the impact of karyotype, results were heterogeneous 269(Bishop et al. 2000; Ergür et al. 2008; Kesler et al. 2004; Larizza et al. 2002; Lepage et al. 2012, 2013c; Loesch et al. 2702712005; Skuse et al. 1997).

272 Several hormonal treatments are prescribed to children and adolescents with TS, such as growth hormone (GH) to in-273274crease adult height and estrogen therapy (around 12 years of 275age) to induce puberty (Bondy 2007). Regarding cognitive profile, no difference was highlighted between girls with TS 276 277 receiving GH and girls receiving placebo (Ross et al. 1997b), 278yet, another study (Rovet and Holland 1993) highlighted improvement of social abilities in the GH group. Furthermore, 279280oxandrolone, an anabolic steroid, is used with GH in children 281 with extreme short stature or when GH treatment is not com-282menced before 9 years of age (Bondy 2007). After several years of treatment, compared to placebo group, girls with TS 283 receiving oxandrolone had better WM abilities (Ross et al. 2842003) and a lower frequency of severe arithmetic learning 285disabilities (Ross et al. 2009). Moreover, positive effects of 286 287an early estrogen treatment on nonverbal processing time, motor speed (Ross et al. 1998), verbal WM, verbal and non-288 verbal episodic memory (Ross et al. 2000) were emphasized 289290 in young girls with TS receiving low doses of estrogen compared to girls receiving placebo. 291

Finally, children with TS reported more depressive and 292 anxiety symptoms (Kiliç et al. 2005; McCauley et al. 2001; 293294Saad et al. 2015) but also a higher prevalence of attention deficit-hyperactivity disorder (ADHD; Russell et al. 2006). 295296As these symptoms are known to be associated with executive 297 impairments in children and adolescents (Han et al. 2016; Ursache and Raver 2014; Wagner et al. 2015; Willcutt et al. 2982005), it would be interesting to consider these psychological 299300 comorbidities in order to improve our understanding of the 301 heterogeneous nature of EF tasks performances.

## 302 **Aims**

Based on Diamond's (2013) hierarchical model of EFs, the
present meta-analysis addresses the following research questions (1) When comparing girls with TS and controls, are there
ES differences across tasks depending on EF abilities tested?
(2) Did children with TS fail only in visual modality EF tasks?
(3) Did participants with TS have lower performance than

controls only in EF tasks that require a rapid response? To309answer these questions, study results, in which EF abilities310of girls with TS were compared to age-matched control girls'311EF abilities, will be analyzed.312

## Methods

The search was conducted following the PRISMA (Preferred314Reporting Items for Systematic review and Meta-Analyses)315guidelines (Moher et al. 2009) and Gates and March's316(2016) recommendations.317

## Study Eligibility Criteria

To be retained in the current meta-analysis, studies had to meet 319 seven criteria (1) all of the patients included were diagnosed 320 with TS, (2) participants were aged between 6 to 18 years, (3) 321 the TS group had to be compared to a control group matched 322 at least by age and sex, (4) children included in the control 323 group had no pediatric or neurological disease, (5) at least one 324 neuropsychological task was used to assess WM, inhibitory 325control, cognitive flexibility or higher-order EFs, (6) data re-326 ported were sufficient to calculate an ES, (7) the article was 327 published in English or French. 328

## Search Strategy

A systematic literature search was performed in September 330 2015 and updated in September 2017 without any restriction 331 of publication date. Five electronic databases (Pubmed, 332PsycARTICLES, PsycINFO, Web of Science Core 333 Collection, and Cochrane Central Register of Controlled 334Trials) were examined. The following combination of key-335 words was used: ("executive" or "cognitive" or "cognition" 336 or "neurocognitive" or "neuropsychological" or "inhibitory 337 control" or "inhibition" or "attention" or "cognitive flexibili-338 ty" or "working memory" or "planning" or "decision mak-339 ing") and ("child\*" or "adolescen\*") and ("Turner syndrome" 340 or "X monosomy" or "sex chromosome abnormalities" or 341"45,X" or "Ullrich-Turner syndrome" or "X chromosome ab-342 normalities" or "X chromosome deletion"). Subsequently, the 343reference section of publications found through our search 344was checked to identify additional studies that may have been 345missed. In addition, when data reported in the article were not 346 sufficient to calculate an ES, the authors were contacted to 347 collect missing data and unpublished results. 348

## **Study Selection**

Initial searches were carried out by two authors (\*\* and \*\*). 350 Both authors were responsible for the exclusion of duplicated 351 records and the screening of titles and abstracts to check 352

eligible studies according to the inclusion criteria. Any discrepancies were resolved by consensus. These studies were
further assessed for eligibility using the full text. Seven authors were contacted to obtain missing data and unpublished
results. Unfortunately, none could respond positively to our
request.

## 359 Data Extraction

Sample Characteristics For each sample, means and standard 360 361 deviation (SD) of age, Verbal IQ (VIQ) and Performance IQ (PIQ) were extracted for TS group and its matched controls. In 362 several studies, the number of participants could vary depend-363 364 ing on the tasks, thus, sample size was extracted for each task. 365 For TS groups, when data were available, the proportion of patients with 45,X karyotype and information concerning hor-366 367 monal treatment (estrogen therapy and growth hormone therapy) were also extracted. 368

369 Executive Function Tasks Neuropsychological measures of EFs were coded separately when assessing one of the follow-370 ing EF components: WM, inhibitory control, cognitive flexi-371372 bility, higher-order EFs. For each task, one variable was se-373 lected as the most appropriate measure of EF. The chosen variable had to be available in all studies included in the me-374 ta-analysis. If data from several variables were present in the 375retained studies, we have selected the one described as the 376 most pertinent measure to assess the targeted EF. This issue 377 378 was raised for three tasks, the TOVA, WCST and SOPT. For 379 the TOVA, the variable "commission errors" has been chosen because, according to Greenberg and Waldman (1993), it al-380381 lows the assessment of impulsivity or response inhibition. Concerning the WCST, the percent of perseverative errors, 382which "may be a better metric of executive function if a single 383 score form the WCST is to be used" (Rhodes 2004, p.488), 384385has been retained. For the SOPT, used in one study, the variable "number of pages before error" has been chosen because 386 387 it seemed to be the most adequate in the assessment of WM 388 abilities compared to the two others (total item perseveration, total position perseveration). Whenever possible, a time vari-389able was also extracted. For each TS group and its control 390 391 group, sample size, mean and SD of each variable (or Fvalue when such data were not available) were extracted. 392 Two studies (Ross et al. 1998, 2000) have examined the ef-393394fects of an early estrogen treatment on girls with TS cognitive 395profile by comparing two subgroups (one group with hormonal treatment and one group without). In these studies, the age 396 ranges were 7 to 9 years (Ross et al. 2000) and 10 to 12 years 397 (Ross et al. 1998). Several other studies retained for the meta-398analyses included participants in the same age ranges, yet 399 400 patients with TS did not receive estrogen treatment. Therefore, only placebo subgroup results were extracted from 401402 these two studies.

### **Data Analysis**

Data analysis was carried out with R software, version 3.2.4.404(R Core Team 2016) using the packages "compute.es" (Del405Re 2013), "MAd" (Del Re and Hoyt 2014), "metaSEM"406(Cheung 2015a), and "metafor" (Viechtbauer 2010). This last407one was also applied to create forest plots.408

The ES was calculated for each variable. As Cohen's d409tends to lead to an overestimation of the ES due to the small 410 samples sizes, Hedge's g correction formula was used to avoid 411 this bias (Borenstein et al. 2009; Hedges 1981). When means 412 and SD were missing, the ES was calculated using F-value. 413 The direction of ES was coded in such a way that a negative 414score corresponded to a greater executive dysfunction of TS 415group. To avoid obtaining a positive g when girls with TS 416 made more errors than control group or had longer response 417 time, the sign of ES had to be reversed for error and time 418 variables. Cohen's criteria (Cohen 1992) were employed to 419 interpret ES. Thus, ES is "small", "medium" or "large" when 420 g value is respectively equal to 0.2, 0.5 or 0.8. For several 421 tasks (verbal fluency tasks, TOL in Temple et al. 1996; digit 422 span subtest in Ross et al. 2000), it was necessary to compute a 423 total score from subscores. Therefore, subscore ESs were 424pooled using Borenstein et al.'s (2009) method. The latter uses 425 the correlation coefficient value to calculate g variance. In line 426 with Scammacca et al. (2014)'s recommendations, this corre-427 lation coefficient value, unknown in the studies included in 428 this meta-analysis, was considered to be equal to 1. 429

In some studies, several tasks have been used to assess EFs. 430Therefore, data extracted from a same group of participants 431would be included several times in the meta-analysis. It was 432necessary to consider the dependence between these ES. A 433 three-level meta-analysis was conducted using the 434maximum-likelihood method to estimate heterogeneity. An 435overall ES was calculated with all the ES. Three different 436levels of heterogeneity are taken into account in this analysis 437 (1) sampling variance of all the ES at level 1, (2) variance 438between ES extracted from the same sample at level 2 and 439(3) variance between ES extracted from different samples at 440 level 3 (Assink and Wibbelink 2016). To test the hypothesis of 441 the homogeneity of ES, the Cochran's Q-test was applied 442 (Cochran 1954). The p-value threshold was fixed to 10%. If 443p-value is less than 0.10, the heterogeneity cannot be consid-444 ered as exclusively due to within-sample error. The level 2 an 445 level 3 heterogeneity variances were estimated with  $\overline{\mathfrak{Y}}^2_{(2)}$  and 446  $\overline{\mathbb{Y}}^2_{(3)}$ , respectively. To quantify the heterogeneity, the I<sup>2</sup> index 447 was calculated.  $I^{2}_{(2)}$  and  $I^{2}_{(3)}$  allow to estimate the proportion 448 of the total heterogeneity of the ES due to the level 2 (within-449 sample) and level 3 (between-sample) heterogeneity. The ef-450fect of moderators (task modality, type of assessed EF) was 451 investigated using a mixed-effects model. In these analyses, 452 $R^{2}_{(2)}$  and  $R^{2}_{(3)}$  estimate the percentage of variance of the het-453erogeneity explained by the moderator at level 2 and level 3 454

455(Cheung 2015b). Following the method introducing by Cheung (2015b), the three-level model has been compared 456to a model in which  $\overline{\mathfrak{Y}}_{(3)}^2$  is set to zero and to a model in 457which  $\overline{\mathfrak{Y}}_{(2)}^2$  is set to zero. To complete the three-level meta-458 analysis, a univariate meta-analysis was conducted for each 459EF task. The random-effects model, which takes into account 460within-sample and between-sample variances, was used to 461conduct these different univariate analyses. 462

463 An overall ES was calculated for each EF task employed in several studies. To assess processing speed 464 465 in girls with TS, an ES was calculated for the response time variable of EF tasks when data were available. In 466 some of these meta-analyses, only a little number of 467 studies could be included. Hence, the results should be 468interpreted with caution. As for the three-level meta-469470 analysis, Cochran's Q-test was used to assess the pres-471 ence of heterogeneity among the ES (Cochran 1954). The parameter 휏<sup>2</sup>, using DerSimonian and Laird meth-472 od, estimates the between-sample heterogeneity variance 473(Borenstein et al. 2009). The  $I^2$  index was calculated to 474 quantify the proportion of total variation due to true 475variability between samples rather than chance. The  $I^2$ 476 477 index estimates what percentage of the observed vari-478 ance would remain if the sampling error could be eliminated (Borenstein et al. 2017). For each univariate me-479 ta-analysis, a funnel plot was produced. The number of 480studies included in this meta-analysis was too low to 481 statistically test funnel plot asymmetry (Higgins and 482483 Green 2011). Therefore, the funnel plots were visually inspected to detect outliers. The leave-one-out method 484 was used to verify the robustness of each univariate 485meta-analysis' results and to assess the impact of out-486 liers on the overall ES. Hence, each analysis was con-487ducted repeatedly removing one study at a time 488 (Viechtbauer 2010). 489

### 490 **Results**

## 491 Characteristics of the Samples

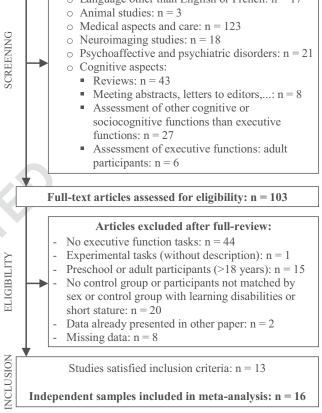


Fig. 1 Flow diagram of selection of studies

Thirteen articles met the seven selection criteria cited 492above. Among these, two publications (Romans et al. 4931997; Ross et al. 1995) included several independent 494495patients groups, each of them being compared to their 496 own control group (matched by age and sex). As a result, sixteen independent samples were retained in 497 the meta-analysis. See Fig. 1 for a flow diagram sum-498 marizing the study's selection process. 499

500 Sample characteristics are summarized in Table 1. In 501 each sample, the TS group and its control group were 502 matched by age and sex. The mean age range was from 503 8.1 to 14.2 years of age for TS groups and 8.4 to

14.3 years of age for control groups. Concerning IQ, 504data were missing in several studies (Bray et al. 2011; 505Rae et al. 2004; Ross et al. 1997a; Temple et al. 1996; 506 Temple 2002). The mean VIQ ranged between 96 and 507107 in TS groups and between 101.5 and 115.3 in con-508trol groups, whereas the mean PIQ ranged between 87.7 509and 95 in TS groups and between 102 and 113 in con-510trol groups. 511

TS groups' characteristics considerably varied between studies. Thus, three studies included only patients 513 with 45,X karyotype (Quintero et al. 2014; Rae et al. 514 2004; Ross et al. 1997a), whereas in other samples, 515 different TS karyotypes (45,X, partial deletion of the 516 second X, different mosaic karyotypes) were mixed. 517 Concerning estrogen therapy, five studies did not 518

580 provide information about treatment received by participants (Bray et al. 2011; Quintero et al. 2014; Rovet 555et al. 1994; Temple et al. 1996; Temple 2002) and these 556data were unknown for several girls in another study 557(Reiss et al. 1995). In several samples, none of the girls 558with TS received this treatment (Rae et al. 2004; Ross 559et al. 1995, 1997a, 1998, 2000, 1997), whereas, in other 560studies, all participants were treated with estrogen (12.5 561to 16.9 years old group in Romans et al. 1997, 1998). 562For GH therapy, information was available in six studies 563564(Romans et al. 1997, 1998, 1995, 1997a, 1998, 2000). The proportion of participants receiving GH was be-565tween 0% and 59%. Concerning EF assessment, the 566567 number of tasks used varied from one to eight among 568studies. The executive tasks, and related variables, used 569 in samples included in the current meta-analysis are 570presented on Table 2.

## 571 Three-Level Meta-Analysis

Overall Score Fifty-six variables assessing performances 572on EF tasks were extracted from fifteen samples. The 573574overall ES was medium and significant (g = -0.67, 95%575C.I. [-0.77, -0.56], Z = -12.19, p < 0.001). The Q statistic indicated significant heterogeneity among the ES 576 (Q(55) = 124.97, p < 0.001). The estimated within-sample 577heterogeneity variance  $(T^2_{(2)})$  was 0.077 and the esti-578mated between-sample heterogeneity variance  $(\overline{\mathfrak{Y}}^2_{(3)})$ 579 was 0.002. According to  $I^2_{(2)}$  and  $I^2_{(3)}$  values, 54.04% 580and only 1.34% of the total heterogeneity were ex-581plained by level 2 and level 3, respectively. See Fig. 2 582for the forest plot. 583

Effects of Moderators The impact of task modality was 584assessed. Overall ES were significant and large for tasks 585in verbal modality (g = -0.86, 95% C.I. [-1.03, -0.70],586Z = -10.38, p < 0.0001) and medium in visual modality 587 (g = -0.57, 95% C.I. [-0.69, -0.45], Z = -9.36,588589 p < 0.001). With this moderator, the estimated heterogeneity variance  $\mathbb{R}^2$  was 0.052 at level 2 and only 5900.003 at level 3. Task modality explained almost 33% 591of the heterogeneity at level 2 ( $R^{2}_{(2)} = 32.65\%$ ), whereas 592the level 3  $R^{2}_{(3)}$  was equal to zero. 593

The impact of the type of assessed EF on the ES was 594595also explored (see Fig. 2). Overall ES varied from small 596 for inhibitory control (g = -0.44, 95% C.I. [-0.60, -0.28], Z = -5.52, p < 0.001) to medium for cognitive 597 flexibility (g = -0.57, 95% C.I. [-0.75, -0.40], Z =598 -6.17, p < 0.001) and large for working memory (g = 599-0.89, 95% C.I. [-1.07, -0.70], Z = -9.42, p < 0.001)600 and higher-order EFs (g = -0.87, 95% C.I. [-1.04, 601 -0.70], Z = -10.05, p < 0.001). With this moderator, the 602 estimated heterogeneity variance  $\overline{\mathbb{R}}^2$  at level 2 and level 603

3 were 0.026 and 0.007, respectively. The type of 604 assessed EF explained almost 66% of the heterogeneity 605 at the level-2 ( $R^2_{(2)}$  = 65.85%), whereas this variable did 606 not explain between-sample heterogeneity ( $R^2_{(3)}$  = 607 0.00%). 608

Comparison between Models The model where between-609 sample heterogeneity variance  $\tilde{\mathbb{Y}}^2_{(3)}$  was set to zero was 610 statistically more suitable than the three-level model 611  $(\chi^2(df=1)=0.02, p=0.88)$ . The three-level model was 612 statistically better than the model where within-sample 613 heterogeneity variance  $\mathbb{R}^{2}_{(2)}$  was fixed to zero ( $\chi^{2}(df =$ 614 1) = 19.24, p < 0.001). Hence, the ES extracted from the 615 same study cannot be considered homogeneous. In a 616 same sample, the ES magnitude could depend on the 617 EF task. Therefore, to explore girls with TS' results 618 for each EF task, several univariate meta-analyses by 619 task have been conducted. In each meta-analysis, each 620 sample was included only once. 621

### Working Memory Tasks

Three tasks were used to assess WM, namely, the Digit 623 Span subtest from the WISC-R (k=8), the SOPT (k=1)624 1), and a n-back task (k=1). Two versions of the SOPT 625 were used in Temple et al.'s study (Temple et al. 1996), 626 a concrete-objects version in which stimuli are drawings 627 of everyday objects and an abstract-objects version in 628 which stimuli are black-and-white patterns. Girls with 629 TS had more difficulties than matched controls, particu-630 larly in the abstract version (g = -1.04), whereas the 631 difference between the two groups was smaller in the 632 concrete version (g = -0.21). In the experimental n-back 633 task (Bray et al. 2011), ES was large in the two modal-634 ities (visual-spatial: g = -0.98; phonological: g = -1.11). 635

A meta-analysis was conducted for the digit span 636 subtest. See Fig. 3 for the visual representation of the 637 results. The ES was large and significant for this task 638 (g = -0.91, 95% CI [-1.07, -0.75], Z = -10.96,639 p < 0.001) and there was no significant difference across 640 the samples  $(Q(6) = 2.15, p = 0.91, \bar{\mathbb{Y}}^2 = 0.00, I^2 =$ 641 0.00%). There was no outlier in the funnel plot (see 642Appendix). According to the leave-one-out analysis, 643 none of the studies had a significant impact on the 644overall ES (ES range from -0.94 to -0.87). Only two 645studies detailed scores for each part of the test, forward 646 and backward digit span (Romans et al. 1998, 2000). 647 Girls with TS were more impaired when they had to 648 recall digits in reversal order. Forward recall ES was 649small or medium (Romans et al. 1998: g = -0.56; Ross 650 et al. 2000: g = -0.48), whereas ES was large for back-651ward recall (Romans et al. 1998: g = -0.91; Ross et al. 6522000: g = -1.06). 653

701 2014), the mean reaction time was higher in the TS 702 group with a small ES in the congruent condition (g = -0.43) and a medium ES in the incongruent condition 704 (g = -0.64).

Conducting a meta-analysis was possible for the TOVA and the MFFT (see Fig. 3). Compared to control participants, girls with TS had less correct answers in the MFFT and made more commission errors in the TOVA. For these two tasks, the ES was small but significant (MFFT: g =-0.34, 95% CI [-0.59; -0.08], Z = -2.57, p < 0.05; TOVA: g = -0.46, 95% CI [-0.64; -0.28], Z = -4.92,

p < 0.001). The *Q*-test did not reveal evidence of heteroge-712neity between studies for the TOVA (Q(5) = 4.56, p = 0.47, 713  $\tau^2 = 0.00, I^2 = <.01\%$ ) but it was significant for the MFFT 714 $(Q(5) = 9.87, p < 0.10, \tau^2 = 0.05, I^2 = 49.33\%)$ . Thus, near 71550% of total heterogeneity would be due to between-716sample heterogeneity in this task. For the MFFT, two sam-717ples were close to the funnel plot limits (see Appendix, 718 Romans et al. 1998; the 10 to 12.5 years old group from 719 Romans et al. 1997). The overall ES range obtained with 720 the leave-one-out method was from -0.43 (without the 10 721to 12.5 years old group from Romans et al. 1997) to -0.25722

723 (without Romans et al. 1998). When the younger sample 724 from Ross et al. (1995) was removed, the results remained 725 no longer significant (g = -0.29, 95% C.I. [-0.58; 0.01], 726 Z = -1.92, p = 0.06). For the TOVA, no outlier has been 727 observed and the results seemed robust. The overall ES 728 range obtained with the leave-one-out method was from 729 -0.50 to -0.41.

730 **Response Time** In the Stroop task, slower responding was 731 observed in the TS group with a medium ES for the reading 732 part (g = -0.53) and large ES for the color-naming (g = -0.99) 733 and the interference (g = -0.97) parts.

734 Concerning the ANT, reaction time was higher in the 735TS group for both incongruent and congruent conditions (see previous part Analysis by task). In the same way, 736 participants with TS were slower than controls in the 737 738other conditions for this attentional task (neutral cue: g = -0.45; no cue: g = -0.55; valid cue: g = -0.49; inva-739 lid cue: g = -0.45). For each condition, response time 740 741 differences between the TS group and its control group were small or, for the no cue condition and the congru-742 ent condition, medium. The difference between the TS 743 744 group and the control group slightly increased with task difficulty (neutral cue vs no cue, congruent vs 745incongruent). 746

For the MFFT, the response time variable can be 747 used to assess impulsivity (Messer 1976). Compared to 748 the previous MFFT meta-analysis, one additional study 749 (Ross et al. 1995), which did not provide the number of 750correct responses but only the mean response time, was 751added to this analysis. There was no significant differ-752753 ence between the TS and control groups (g = 0.13, 95%) CI [-0.04; 0.30], Z = 1.55, p = 0.12). There was no sig-754nificant heterogeneity across the seven samples (Q(6) =7556.02, p = 0.42,  $\tau^2 = 0.00$ ,  $I^2 = 0.00\%$ ). No outlier was 756 757 identified in the funnel plot (see Appendix). In the leave-one-out method, the overall ES range was from 7580.07 to 0.20. The meta-analysis results became signifi-759760 cant when one sample was removed (the 10 to 12.5 years old group from Romans et al. 1997) but 761the ES remained small (g = 0.20, 95% CI [0.01; 0.38],762 763Z = 2.08, p < 0.05).

764 In the TOVA, response time variable may assess information processing speed and motor response speed 765766 (Greenberg and Waldman 1993). Girls with TS were faster than control participants and the difference be-767 tween TS and control groups was small and significant. 768(g = 0.32, 95% CI [0.11; 0.54], Z = 2.96, p < 0.01). The 769 results were not significantly different across the six 770samples  $(Q(5) = 6.90, p = 0.23, I^2 = 27.50\%)$ . One outlier 771(youngest group from Ross et al. 1995) was observed in 772 the funnel plot (see Appendix). When this sample was 773 774 removed, overall ES value increased but remained small 779

(g = 0.42, 95% CI [0.22; 0.62], Z = 4.08, p < 0.001). The 775 meta-analysis results seemed to be robust. The range of 776 overall ES obtained with the leave-one-out method was 777 from 0.27 to 0.42. 778

## **Cognitive Flexibility Tasks**

The WCST (k=5), the phonemic (k=8) and semantic 780 verbal fluency tasks (k=3) were used to assess cogni-781 tive flexibility abilities. In the WCST (see Fig. 3), girls 782with TS did not make significantly more perseverative 783 errors than control participants. The ES was small and 784non-significant (g = -0.17, 95% CI [-0.51; 0.17], Z =785-0.98, p = 0.33). The Q-test was significant (Q(4) = 786 8.44, p < 0.10,  $\tau^2 = 0.08$ ). The  $I^2$  index indicated that 787 52.62% of the total variation would be due to heteroge-788 neity between samples. One sample (the 10 to 12.5 years 789 old group from Romans et al. 1997) was close to funnel 790 plot limits (see Appendix,). When this sample was re-791 moved, overall ES got closer to zero (g = -0.06, 95%)792 CI [-0.53; 0.34], Z = -0.43, p = 0.67). According to the 793 leave-one-out method (ES range from -0.30 to -0.06), 794the meta-analysis results were consistent. The ES 795 remained small and non-significant regardless of the re-796 moved study. 797

Concerning the verbal fluency tasks (see Fig. 3), girls with 798TS named significantly less words than controls in the two 799 conditions (phonemic: Z = -3.31, p < 0.001; semantic: Z =800 -5.87, p < 0.001). For the phonemic tasks, ES was medium 801 (g = -0.69, 95% CI [-1.10; -0.28]), whereas it was large for 802 the semantic tasks (g = -0.92, 95% CI [-1.23; -0.61]). The Q-803 test did not reveal heterogeneity between studies for semantic 804 fluency tasks (Q(2) = 1.11, p = 0.57,  $\tau^2 = 0.00$ ,  $I^2 = 0.00\%$ ), 805while the results were significantly heterogeneous for the pho-806 nemic fluency tasks ( $Q(7) = 20.05, p < 0.01, \tau^2 = 0.21$ ). 807 According to the  $I^2$  index, 65.08% of the total variability 808 among ES would be caused by heterogeneity across the eight 809 samples. Three outliers were identified in the funnel plot 810 representing phonemic tasks' ES (Rae et al. 2004; Romans 811 et al. 1998; Temple 2002). Without Rae et al. (2004), overall 812 ES became large (g = -0.81, 95% CI [-1.19; -0.42], Z =813 -4.10, p < 0.001) whereas when the two other outliers were 814 removed, overall ES remained medium and close to the over-815 all ES value calculated with all samples' results (without 816 Romans et al. 1998: g = -0.60, 95% CI [-1.08; -0.11], Z =817 -2.41, p < 0.05; without Temple 2002: g = -0.58, 95% CI 818 [-0.99; -0.16], Z=-2.70, p<0.01). Concerning semantic 819 verbal fluency task, no outlier was observed in the funnel plot 820 (see Appendix), but this task has been used in only three 821 samples. The meta-analysis results should be interpreted with 822 caution. Indeed, the overall ES became medium when one 823 sample (Romans et al., Romans et al. 1998) was removed 824 (g = -0.70, 95% CI [-1.26; -0.14], Z = -2.45, p < 0.05).825

### Discussion

Time Variables There was no time variable in the WCST. For the verbal fluency tasks, response time limit is 60 s. Thus, the number of correct responses may reflect processing speed. In a same period, the girls with TS produced significantly less words than controls (see previous section Analysis by task).

## 832 Higher-Order Executive Functions Tasks

Three tasks were used to assess higher-level EFs, namely, the ROCF (k = 8), the TOL (k = 1), and the TOH (k = 4). In the TOL used in Temple et al.'s study (Temple et al. 1996), the TS group obtained lower scores than its matched controls but the ES was small (g = -0.15).

A meta-analysis was conducted using results obtained in 838 839 the TOH (see Fig. 3), another problem solving task. Girls with 840 TS scored significantly lower than the control participants resulting in a medium ES (g = -0.66, 95% CI [-0.93; 841 -0.40], Z = -4.99, p < 0.001). The Q-test did not indicate sig-842 843 nificant heterogeneity between samples (Q(3) = 2.15, p =844 0.54,  $\tau^2 = 0.00$ ,  $I^2 = 0.00\%$ ). No outlier was identified in the funnel plot (see Appendix). The overall ES obtained with the 845 846 leave-one-out method were close to the ES obtained when all 847 samples were included (ES range from -0.72 to -0.56). Hence, the meta-analysis results could be considered as 848 robust. 849

In the ROCF (see Fig. 3), the TS group's copy score was 850 lower than control group's score and the ES was large and 851 significant (g = -0.98, 95% CI [-1.12; -0.83], Z = -13.03, p 852 853 < 0.001). The results were homogeneous (Q(7) = 4.58, p =0.71,  $\tau^2 = 0.00$ ,  $I^2 = 0.00\%$ ). In the funnel plot (see 854855 Appendix), one study (the older group in Ross et al. 1995) was close to the funnel limits. Removing this sample did not 856 have an impact on the overall ES (g = -0.94, 95% C.I. [-1.09; 857 -0.78], Z = -12.08, p < 0.001). According to the leave-one-858 859 out method (ES range from -1.01 to -0.94), the metaanalysis results were consistent. 860

861 Time Variables The time required to reproduce the ROCF was not reported in the studies included in this meta-862analysis. Concerning the tower tasks, in the four sam-863 ples using the TOH, girls with TS had slower perfor-864 mances when resolving items. The difference between 865 TS and control groups was large and significant (g =866 867 -0.95, 95% CI [-1.22; -0.68], Z = -6.93; p < 0.001). There was no significant between-sample heterogeneity 868  $(Q(3) = 2.86; p = 0.41, \tau^2 = 0.00, I^2 = 0.00\%)$ . No outlier 869 was identified (see Appendix) and the results seemed 870 robust according to the leave-one-out method (ES range 871 from -1.00 to -0.84). In the TOL task used only by 872 Temple et al. (1996), girls with TS were also slower 873 874 than controls but, in this task, the difference between 875 the two groups was small (g = -0.16).

The aim of this review was to explore EF profile char-877 acteristics in children and adolescents with TS. Even if 878 these girls' EF abilities have been assessed in several 879 studies, methodologies previously used present some 880 limitations and vary from one publication to another. 881 The current meta-analysis results provide evidence that 882 girls with TS suffer from executive impairments and 883 support the argument suggesting the fractionation of 884 EFs processes (Diamond 2013; Lehto et al. 2003; 885 Miyake et al. 2000). WM and higher-order EFs seem 886 to be the most affected processes, whereas some aspects 887 of inhibitory control and cognitive flexibility may be 888 more preserved in these young patients. 889

### **Executive Functions Impairments in Turner Syndrome** 890

In the three-level meta-analysis, the overall ES was neg-891 ative and medium, corroborating the argument that girls 892 with TS have executive impairments. However, this re-893 sult should be interpreted in light of the within- and 894 between-sample variability. Indeed, between-sample het-895 erogeneity was surprisingly lower than the within-896 sample heterogeneity. Only fifteen studies have been 897 included in this meta-analysis and, among them, the 898 number of outcome variables ranged from one to eight. 899 A negative and large ES was obtained for each of the 900 studies in which only one variable was extracted (Reiss 901 et al. 1995: ROCF: g = -0.94; Ross et al. 1997a, b: 902Q3 ROCF: g = -0.90; Rovet et al. 1994: Digit span subtest: 903 g = -0.92; Temple 2002: phonemic verbal fluency task: 904 g = -1.54). Between-sample heterogeneity would have 905been higher if, in some of these studies, the authors 906 had used a task in which small differences between girls 907 with TS and controls have been observed (e.g. MFFT). 908 Moreover, four studies, in which seven or eight vari-909 ables were extracted, were conducted by the same re-910 search team (Ross et al. 1997a, b; Romans et al. 1998). 911**Q4** The authors investigated different EFs, used the same 912 tasks and obtained heterogeneous results in the four 913 studies. Within-sample heterogeneity would have been 914 lower if, in some studies, the authors had explored only 915 one EF with several tasks (such as Bray et al. 2011). 916 Indeed, according to moderator analysis, the type of 917 assessed EF might explain a large part of within-918 sample heterogeneity. 919

In the present study, large WM deficits in children 920 and adolescents with TS were highlighted through tasks 921 used to assess visual-spatial or verbal WM, except for 922 one, the concrete version of the SOPT (Temple et al. 923 1996). There are at least three possible hypotheses to 924 explain this performance in the SOPT. One proposed 925

by Temple et al. (1996) suggests that girls with TS may 926 have difficulties when stimuli are non-verbal or when 927 they cannot adopt a verbal strategy to support executive 928 processes. However, the results did not totally confirm 929 930 this hypothesis:, impairments have been highlighted both on executive non-verbal tasks (visual-spatial n-back 931 task, abstract version for the SOPT) and verbal ones 932 (digit span and auditory n-back tasks in which a verbal 933 strategy could be used). A second possible explanation 934 of the concrete version of SOPT results is that, in this 935 936 task, other processes are involved such as selfmonitoring which could be preserved in girls with TS. 937 Yet, this hypothesis cannot explain performances dis-938 crepancies between the two versions of SOPT. A third 939 explanation is to suppose that self-monitoring might be 940 efficient in girls with TS only in tasks where double-941 942 coding could be involved (Paivio 1971).

The association between TS and inhibition impair-943 ment varied across inhibitory measures. In the three 944 Stroop conditions, a cognitive inhibition task, girls with 945TS were slower than controls. The Stroop effect value 946 (g = -1.01) may suggest that these girls have significant-947 ly more difficulties inhibiting a prepotent response when 948 compared to controls. The other inhibitory processes 949 described by Diamond (2013), focused attention and re-950 sponse inhibition, seem to be more preserved in girls 951 with TS. Thus, they were slower than controls in the 952 ANT (a focused-attention task), but this difference in 953 response time was quite similar among the six condi-954955 tions of ANT despite different difficulty levels (ES range from -0.64 to -0.45). Therefore, a slower pro-956957 cessing speed in girls with TS compared to their matched controls may explain differences observed be-958tween the two groups. As for response inhibition, even 959 if children with TS had more difficulties than their 960 961 healthy peers to inhibit impulsive behaviors, differences with controls were small for the accuracy and response 962 time variables in tasks assessing impulsivity. 963

964 Concerning cognitive flexibility, a discrepancy was found between the tasks used to explore this function. 965Compared to healthy controls, girls with TS had signif-966 icantly lower performance on verbal fluency tasks with 967 medium to large ES, whereas there was no significant 968 difference between groups in the WCST. Two hypothe-969 970 ses can be advanced to explain these differences. First, maybe these tasks do not assess the same aspects of 971 cognitive flexibility. Eslinger and Grattan (1993) distin-Q5 972 guished spontaneous flexibility, assessed by fluency 973 tasks that require generation of diverse answers, versus 974 reactive flexibility, assessed by the WCST where partic-975 ipants need to adapt their answers to the examiner's 976 demands or to stimuli. In TS, spontaneous flexibility 977 978 may be impaired whereas reactive flexibility may be

more preserved. The second explanation is that the im-979 pairment observed in verbal fluency tasks could be due 980 to the fact that participants have a limited period of 981 time to generate as many words as possible. In the 982 present meta-analysis, this time constraint was absent 983 in the WCST in which the chosen variable was the 984number of perseverative errors. Differences observed 985 across cognitive flexibility tasks may be attributed, at 986 least in part, to a slowdown in information processing 987 speed. 988

According to Diamond's model (2013), the three core 989 EFs contribute to higher-order EFs. However, conflict-990 ing results have been reported under the type of plan-991 ning task used. Hence, children with TS took more time 992 to complete the TOH and could not reach the same 993 level as that of controls (a medium ES was found). In 994 contrast, in the case of TOL a small difference was 995 found between the TS group and the control group 996 concerning both the accuracy score and response time. 997 While these two tasks appear to be very similar, they 998 may involve different cognitive processes. For instance, 999 it has been suggested that WM and inhibition may be 1000 related to TOL results, whereas only inhibition may 1001 contribute to TOH performance (Welsh et al. 1999). In 1002 contrast, Zook et al. (2004) have proposed that only 1003 fluid intelligence measure was related to scores of the 1004 TOL, whereas WM, inhibitory response, fluid intelli-1005 gence, and TOH performances were correlated. The cur-1006 rent meta-analysis results are congruent with those ob-1007 tained by Zook et al. (2004). Planning abilities have 1008 also been assessed with the ROCF. Large differences 1009 between girls with TS and healthy controls were ob-1010 served, yet, this could be explained by impairments ob-1011 served in patients with TS in visual constructional abil-1012 ities which are necessary in succeeding this task. 1013

## Visual-Spatial Impairment and EFs in Girls with Turner 1014 Syndrome 1015

According to Temple and Carney (1995) who assessed 1016 different aspects of visual functions in TS, difficulties 1017 may affect more specifically visual-perceptual and 1018 visual-constructional abilities but visual-spatial capaci-1019 ties seem to be preserved. However, this hypothesis 1020 has not been supported by clinical data. Several studies 1021have suggested that underperformance of girls with TS 1022 on Benton's Judgement of Line Orientation task or the 1023Arrows subtest from the NEPSY may suggest that they 1024 also present visual-spatial deficits (Bray et al. 2013; 1025 Green et al. 2014; Kesler et al. 2004). When task mo-1026dality was used as moderator, the estimated ES was 1027 large for verbal tasks (g = -0.86, 95% C.I. [-1.03, 1028 -0.70]), whereas it was medium for visual tasks (g = 1029

1030 -0.57, 95% C.I. [-0.69, -0.45]). Hence, even if visualspatial difficulties could explain poor performances on 1031 executive tests which involve visual stimuli, it may not 1032 fully explain impairments reported in other tasks 1033assessing verbal WM or verbal fluency. Moreover, 10341035 Bray et al. (2011) have proposed an innovative methodology which contrasts two versions of a WM task, one 1036 based on phonological processing and one based on 1037 1038 visual-spatial processing. This method has highlighted that girls with TS were impaired in both modalities. 10391040 Unfortunately, it was the only study included in the current analysis allowing the comparison of modality 1041 specificity within the same EF. 1042

1043 Links between visual-spatial impairments and EFs have been explored in other studies, which did not meet the 1044 inclusion criteria for this meta-analysis. In Lepage et al. 10451046(2011), girls with TS had significantly lower scores than controls on the Attention-Executive Domain of the 1047 1048 NEPSY. Performances of patients with TS on Tower and 1049 Visual Attention subtests were significantly and positively correlated to subtests from Perceptual Reasoning Index 1050 score of the WISC-IV. This association was not observed 10511052in the control group. These results are interesting but it is unclear if the TS results on EF tasks were due exclusively 1053to EF impairment or if the visual nature of stimuli accen-1054tuated impairments. In another study (Green et al. 2015), 1055girls with TS were divided in two sub-groups according to 1056 the severity of ADHD-associated behaviors and were 10571058compared to neurotypical children as well as to children with idiopathic ADHD. All girls with TS had lower re-1059sults than neurotypical controls in all the NEPSY do-1060mains. The two TS groups had the same profile compared 1061to children with idiopathic ADHD, except for visual-1062spatial tasks in which girls with TS had poorest results. 1063 There was no difference between the two TS groups in 1064visual-spatial EF tasks but girls with TS with ADHD-1065associated behaviors had lower results on auditory EF 1066 tasks than the other ones without ADHD. Therefore, an 10671068EF deficit, at least partially independent of visual-spatial impairments, could be observed in girls with TS and may 1069be associated with the ADHD profile, a variable, among 1070 others, that should be considered when performances in 10711072 EF tasks are analyzed.

# 1073 Moderator Variables of Executive Functions1074 in Children with Turner Syndrome

1075 In the current meta-analysis, heterogeneous results across 1076 samples were observed for three EF tasks, the MFFT, the 1077 phonemic fluency verbal task, and the WCST. Several 1078 variables could explain these ES differences between 1079 samples.

As suggested in the Introduction, some aspects of 1080 EFs are considered as part of the intelligence construct. 1081Heterogeneous results could be explained by IQ differ-1082ences between the different samples in which these EF 1083 tasks have been used. Indeed, correlations between IQ 1084and EF tasks, including MFFT, WCST and phonemic 1085 verbal fluency task, have been previously highlighted 1086in developmental data (MFFT: Messer 1976; Fluency 1087 verbal tasks: Anderson et al. 2001; WCST: Ardila 1088 et al. 2000). Given the lack of relevant data, this hy-1089pothesis could not be explored in this meta-analysis. 1090

In the current review, seven studies found no significant 1091 difference in SES between TS and control groups (Reiss 1092 et al. 1995; Romans et al. 1997, 1998; Ross et al. 1995, 1093 1997a, 1998, 2000). Two studies specified that children in-1094cluded were from mainstream schools (Temple et al. 1996; 1095 Temple 2002) and three studies did not mention this variable 1096 (Bray et al. 2011; Quintero et al. 2014; Rae et al. 2004). Due to 1097 the lack of information, it was not possible to statistically 1098 control for SES influence on ES in the current meta-analysis. 1099 However, given that in the majority of studies there was no 1100 significant difference in SES between the two groups, an ef-1101 fect of this variable on the meta-analysis results seems to be 1102 unlikely. 1103

Different types of X chromosome abnormalities lead 1104 to a diagnosis of TS, and differences across karyotypes 1105 could explain variability in EF profiles. Unfortunately, it 1106 was not possible to assess the impact of karyotype on 1107 ES in the current meta-analysis. The proportion of pa-1108 tients with 45,X karyotype was unknown in several 1109 samples. Among the studies included in the current 1110 analysis, three compared the 45,X group to the other 1111 karyotypes groups (Bray et al. 2011; Ross et al. 1995; 1112Temple et al. 1996). These studies did not find a sig-1113 nificant effect of karyotype on EF except for the SOPT 1114 (Temple et al. 1996). In the abstract version of this task, 1115girls with a 45,X karyotype had poorer performances 1116than the group including participants with TS with var-1117 ious karyotypes (mosaic patterns, partial deletions, trans-1118 locations). Significant differences were mentioned be-1119 tween 45,X and mosaic groups in subtests of perceptual 1120 reasoning index and WM index from the WISC-IV 1121 (Bray et al. 2011) where the mosaic group was less 1122impaired in several measures but the authors did not 1123detail the results. In light of the possible impact of 1124karyotype upon cognitive profile, it may be relevant 1125(when the number of participants allows to conduct sol-1126id statistical analysis) to create different sub-groups un-1127 der the TS karyotype. 1128

Girls with TS receive GH treatment and, several 1129 years later, estrogen therapy. The influence of GH could 1130 not be explored in the current analysis due to the lack 1131 of relevant data. In a study not included in this review 1132

1133(absence of control group; Ross et al. 1997b), participants who received GH and those who received placebo 1134obtained similar performances on all cognitive tasks in-1135cluding EF tasks (MFFT, TOVA, ROCF, digit span sub-1136 test). Concerning the potential impact of estrogen treat-1137ment on EF abilities, only two samples among the six-1138 teen included in the present analysis (Ross et al. 1998, 11392000) detailed results regarding estrogen status. Three 1140 EF tasks were used - a digit span subtest, a phonemic 1141 verbal fluency task (Ross et al. 2000), and the MFFT 11421143(Ross et al. 1998) - and a difference was observed across the participants with TS only on the digit span 1144 backward. There was no difference between healthy 1145controls and estrogen-treated TS group whereas 1146 placebo-treated TS group had significantly lower results 1147 than controls (Ross et al. 2000). However, the lack of 1148 1149 information in the other included samples (k=14) is a barrier when further exploring the impact of this treat-1150ment upon EFs in girls with TS. The role played by 11511152estrogen in brain development and neuroplasticity, as well as its neuroprotective effects (Crider and Pillai 11532016), strengthens the argument that estrogen therapy 1154could improve cognition in TS. Therefore, compliance 11551156regarding this therapy, prescribed in most patients with TS (Bondy 2007), must be taken into account when 1157cognitive processes are assessed. Some cognitive differ-1158ences across adolescents with TS may be partially ex-1159plained by the variation in compliance behaviors. These 1160hormonal treatments may also have positive effects on 1161 psychological well-being in girls with TS (Ross et al. 11621996; Rovet and Holland 1993), another moderator var-1163iable that may have an impact on EF abilities. 1164

The prevalence of psychiatric disorders, such as anx-1165iety, depression, or ADHD, is higher in patients with TS 1166 (Kiliç et al. 2005; McCauley et al. 2001; Russell et al. 1167 2006; Saad et al. 2015). Among the studies retained, 1168 depression, anxiety, and ADHD symptoms were 1169assessed in only one study (Reiss et al. 1995). There 1170 1171 was no significant difference between the TS group and the control group on depression or anxiety items of the 1172Child Behavior Checklist but the children with TS had 1173significant higher scores than the control group on the 1174attention and social problem scales. Authors did not 1175analyze the association between these scores and perfor-1176 1177mances on EF tasks. To our knowledge, the impact of depression or anxious symptoms upon cognitive skills 1178has never been explored in children and adolescents 1179with TS. Considering negative effects observed in pop-1180 ulations presenting these symptoms (Han et al. 2016; 1181 Ursache and Raver 2014; Wagner et al. 2015), these 1182aspects should also be considered in TS to improve 1183the understanding of these girls' cognitive profileS and 1184to adapt their psychological care and rehabilitation. 1185

## Impact of Executive Functions Impairments 1186 in Children with Turner Syndrome 1187

Children and adolescents with TS present mathematical 1188 impairments (Baker and Reiss 2016; Mazzocco 1998; 1189Mazzocco and Hanich 2010; Murphy and Mazzocco 1190 2008). Many studies highlighted significant associations 1191 between EFs, most particularly WM abilities, and math-1192 ematics (e.g. De Smedt et al. 2009; Gathercole et al. 1193 2004). In children with TS, there was no correlation be-1194 tween Calculations score from Woodcock-Johnson 1195Psychoeducational Battery-Revised and executive tasks 1196 such as a digit span backward subtest (Murphy and 1197 Mazzocco 2008). Another study explored the impact of 1198increasing WM demand on tasks which assess automa-1199 ticity and accuracy of participants to compose and de-1200 compose numbers. It appeared that, in girls with TS, 1201 WM abilities may be involved in numerical tasks which, 1202 in contrast, are supposedly effortless in control children 1203 (Mazzocco and Hanich 2010). Furthermore, a positive 1204correlation between visual-spatial results and those ob-1205 tained in a symbolic numerical magnitude comparison 1206task has been also described in girls with TS but not in 1207 control participants (Brankaer et al. 2016). Associations 1208 between WM, or other EFs, and mathematic disabilities 1209 in TS are not yet clear and need to be further explored in 1210 future researches. 1211

Many studies highlighted social disabilities in girls with 1212 TS (Hong et al. 2011; Lepage et al. 2013b; Lesniak-1213 Karpiak et al. 2003; McCauley et al. 1995, 2001; Reiss 1214 et al. 1995). A deficit in emotion recognition has been 1215described (McCauley et al. 1987; Romans et al. 1998; 1216 Hong et al. 2014), yet theory of mind abilities have been 1217 assessed in only two studies and the results were conflict-1218 ing (Hong et al. 2011; Yamagata et al. 2012). Theory of 1219mind abilities play a crucial role to adopt behaviors appro-1220 priate to social situations and several EFs, such as inhibi-1221 tion and WM could be involved in theory of mind abilities 1222(e.g. Austin et al. 2014; Carlson et al. 2002). Thus, WM 1223 and cognitive inhibition impairments observed in girls with 1224TS might be associated with theory of mind weaknesses 1225and social difficulties in these young girls. 1226

## **Limitations and Future Directions**

1227

Even if this meta-analysis improves knowledge of EF pro-1228 file of children and adolescents with TS, these results 1229 should be interpreted in light of some limitations. This 1230 syndrome is a heterogeneous rare disorder and, unfortu-1231nately, few research teams have been interested in EF abil-1232ities of patients with TS. The number of studies respecting 1233 all inclusion criteria was small and the methodology var-1234ied. It was not possible to explore the potential effects of 1235

1236the participant characteristics upon EF performances. Insufficient information regarding variables which can 1237have an effect on observed findings (i.e. IQ, age, karyo-1238type, co-morbid psychiatric disease, hormonal status) was 1239 available in the majority of the studies included in the 1240 1241 current review. The small number of studies did not allow elimination of those conducted by the same research team. 1242 1243 Therefore, the possibility that some girls with TS were 1244 included in several studies at different ages or that same results were used in different studies cannot be rejected. 1245

1246Another limitation comes from the nature of EF tasks. The different tasks retained in the current analysis could 1247 reflect different cognitive abilities. It was the case for 1248 example in the Tower tasks, as previously indicated, this 12491250task may target different cognitive processes depending on the version. Some tasks using different type of stimuli 12511252(e.g. the SOPT) would be more discriminant than simpler EF tasks. In addition, in the current analysis, planning and 1253 inhibitory control have been assessed exclusively with 12541255tasks in which visual-spatial abilities operate. Therefore, the role played by the visual-spatial deficit on executive 1256impairments must be considered. It is plausible to suggest 12571258that EF assessment in this population includes both verbal 1259and visual tasks for each EF. Another possibility to differentiate the visual-spatial deficit and EFs impairments 1260 would be to decompose EF tasks, as Roy et al. (2010) 1261have done to assess planning abilities in children with 1262 neurofibromatosis type 1. These authors used two condi-12631264tions of the ROCF copy, namly, the "Formulation" condition (similar to the classic task) and the "Execution" con-1265dition. In this last condition, planning abilities play a less 1266important role. Five sheets are successively presented to 1267children. In each sheet, different elements of the ROCF 1268are progressively added. Therefore, the children reproduce 1269 the figure by including progressively in their drawings the 12701271elements that appear in each new sheet presented. A significantly higher score in the "Execution" condition when 1272compared to the "Formulation" condition provides argu-12731274 ments in favor of planning impairments.

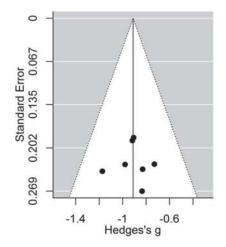
Finally, the present meta-analysis was focused exclusively 1275in pencil-and-paper EF tasks or computerized EF tasks. To 1276our knowledge, only one study explored the impact of exec-1277utive dysfunctions in daily lives of girls with TS (Lepage 1278et al. 2013b) where authors administrated the Behavior 12791280Rating Inventory of Executive Function (BRIEF; Gioia 1281 et al. 2002). The BRIEF is a questionnaire which assesses executive impairments in daily life at home, with the Parent 1282Form, and at school, with the Teacher Form. Lepage et al. 1283 (2013b) used the Parent Form and the results revealed that 1284there were more complaints concerning EF difficulties in the 12851286TS group in comparison with the control group. It would be interesting to confirm these results, with Parents and Teacher 1287forms, and compared them to EF task performances. 1288

## Conclusion

This systematic review and meta-analysis confirms the pres-1290ence of EF impairments in girls with TS. Difficulties seem to 1291 affect particularly WM and higher-order EFs. Self-regulation 1292and reactive flexibility abilities appear to be less impaired. Girls 1293 with TS were slower than controls in several EF tasks yet this 1294 slower processing speed did not totally explain poor perfor-1295mances observed in cognitive inhibition and problem-solving 1296 timed tasks. Given visual-spatial impairments described in TS, 1297in order to improve our understanding of these patients' EF 1298 profile, each EF should be assessed through tasks in visual-1299spatial modality and tasks in verbal modality. Moreover, the 1300 use of decomposed EF tasks could help distinguish the different 1301 processes involved. Several moderator variables should be con-1302trolled, such as SES, IQ, karyotype, presence of psychological 1303comorbidities, or compliance to the hormonal treatment. A bet-1304 ter understanding of EF impairments could help to explore 1305 difficulties encountered by girls living with TS, such as math-1306 ematical difficulties or social disabilities. 1307

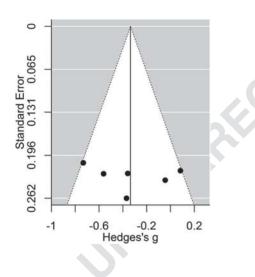

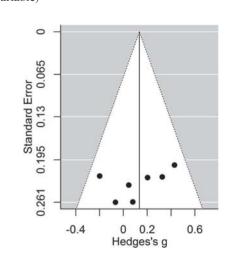

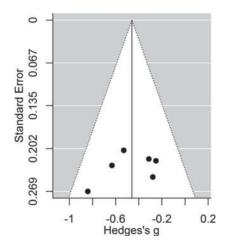

- 1338Errors)



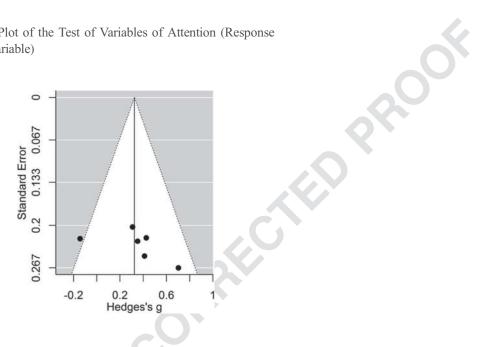

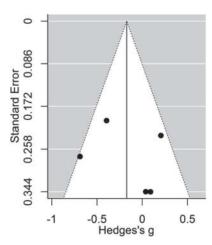

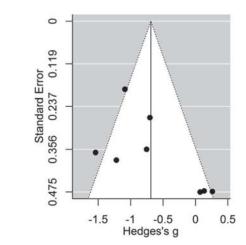

Funnel Plot of the Phonemic Verbal Fluency Task 1352

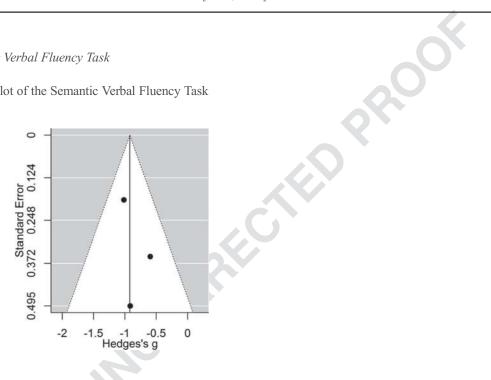

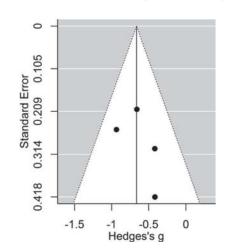

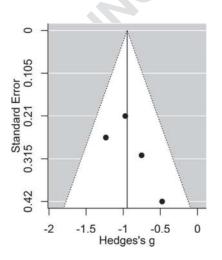

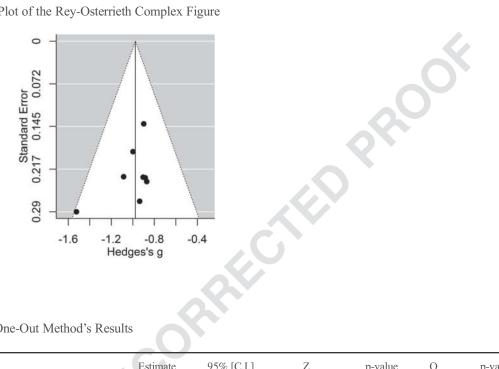
